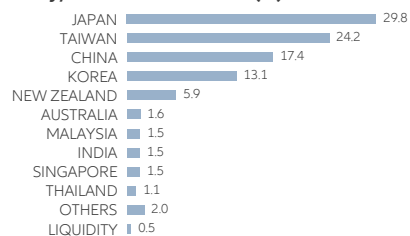

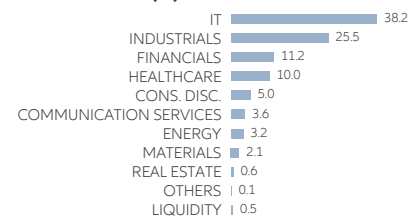
Asset Allocation (%)
