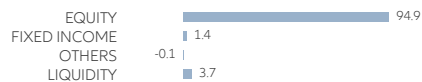

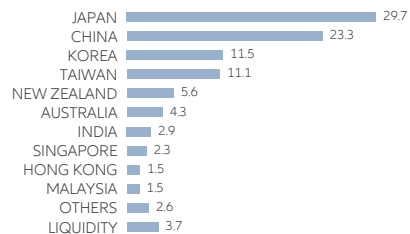

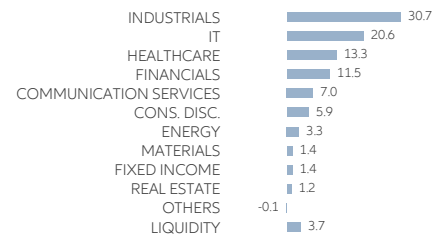
Asset Allocation (%)
