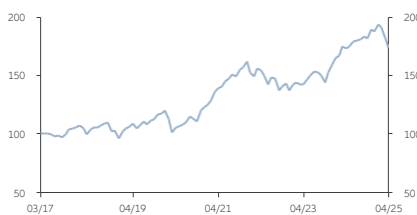

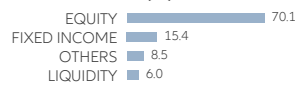

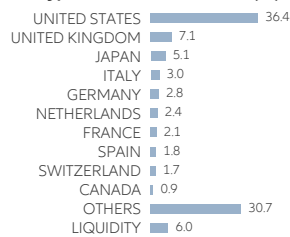

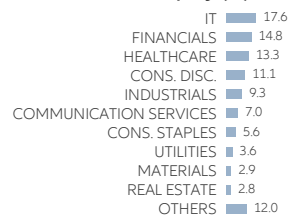
Asset Allocation (%)



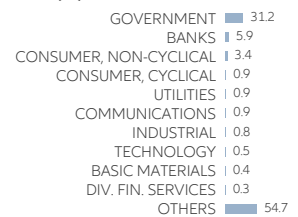
Country/Location Allocation (%)
