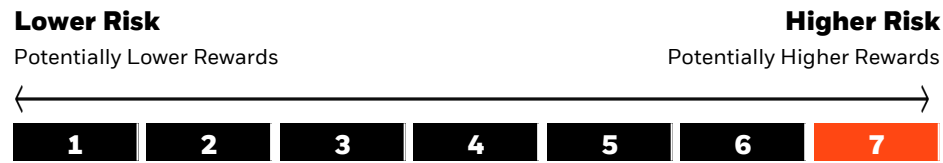

FUND OVERVIEW

- The Fund invests globally at least 70% of its total assets in the equity securities (e.g. shares) of companies the main business of which is in the technology sector.

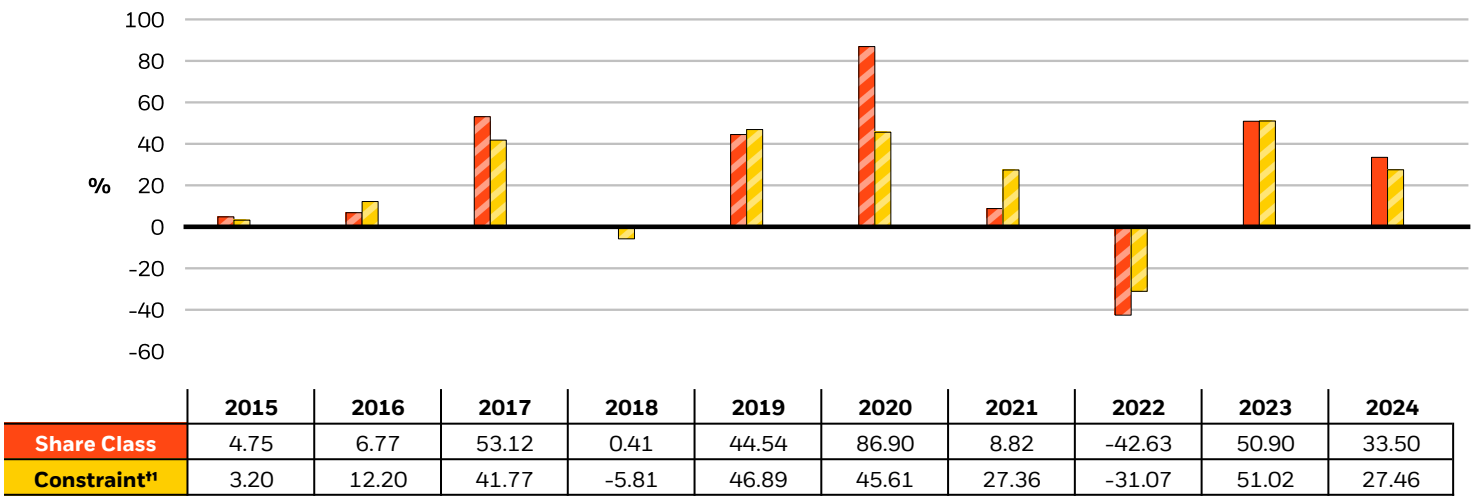

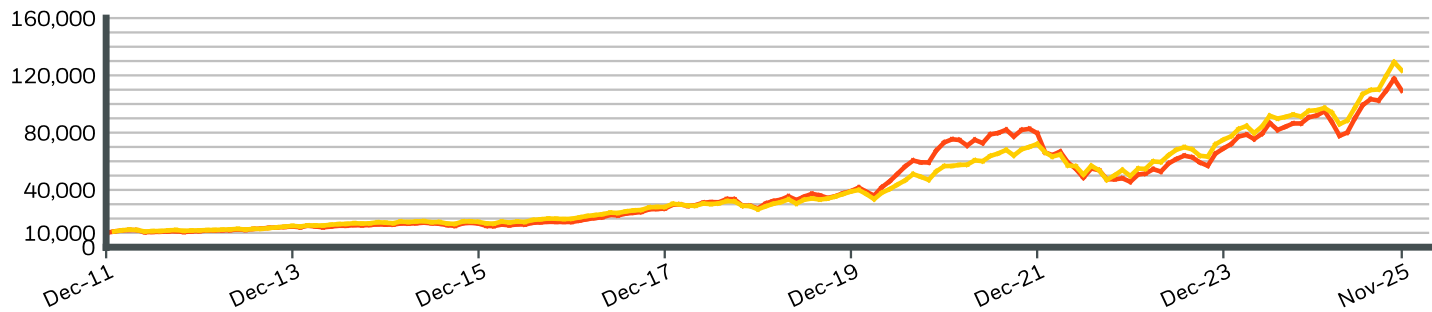

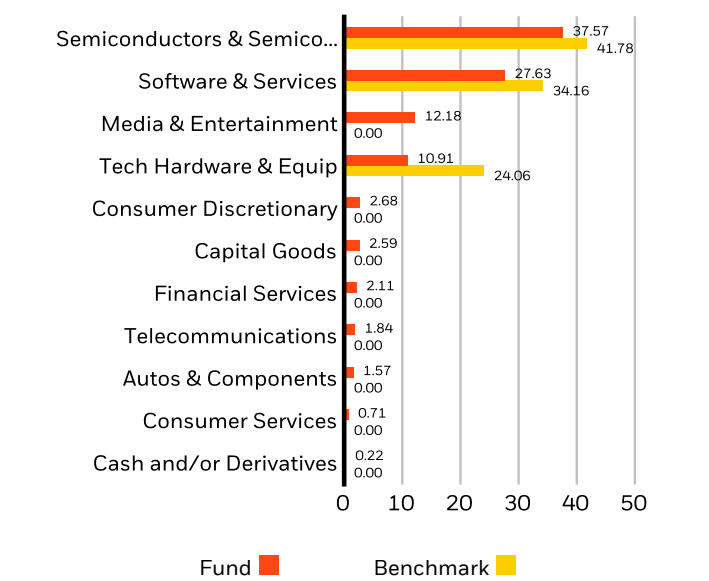

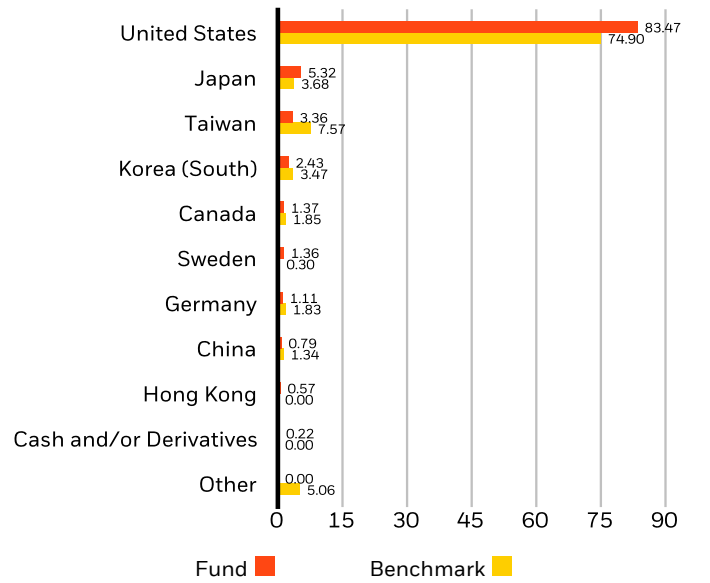

SECTOR BREAKDOWN (%)



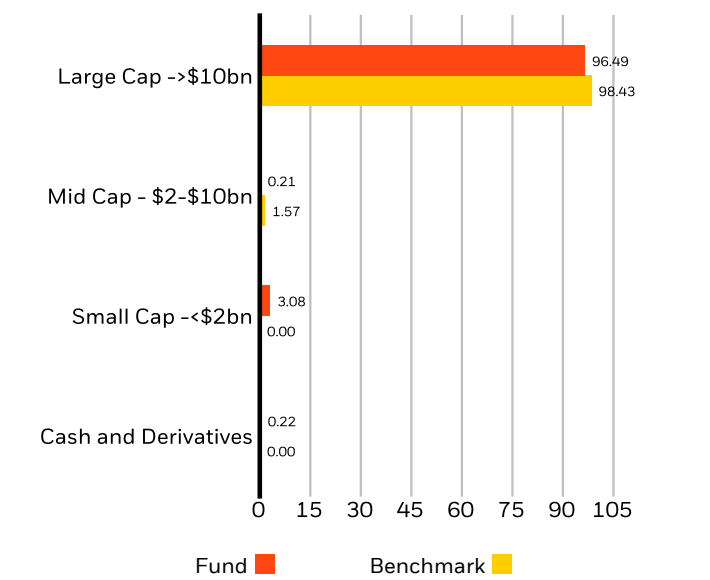
