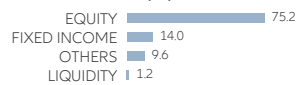
Indexed Performance since Inception (Bid-Bid)



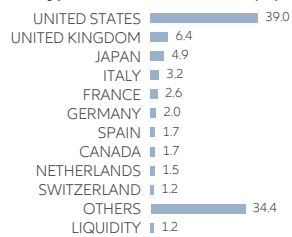

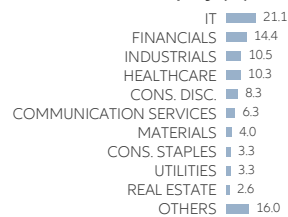
Asset Allocation (%)



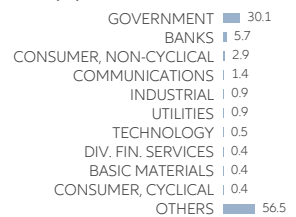
Country/Location Allocation (%)
