JPMorgan Japan (Yen) Fund

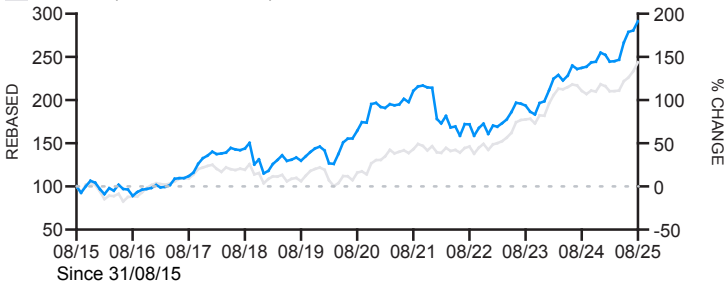

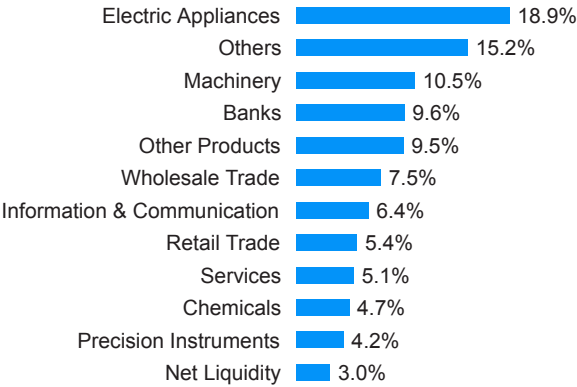
